The applicant attended and explained that he had recently purchased the land and intended to build a single storey 5 bed dwelling on the site of the dilapidated buildings. They intend for the property to be a long-term family home rather than a development project to sell. They are happy to work with the council to reach an agreeable proposal.

Cllr Brand outlined that the buildings are beyond repair and that the proposed dwelling is in keeping with the existing footprint, is single storey to ensure minimal impact and will be constructed from red brick, render and zinc materials. An ecological appraisal has been completed and recommendations given regarding the creation of a pond, hedgerows and areas of wildflowers to enhance the area and encourage wildlife.

It was noted that there were 4 objections lodged with Mendip District Council planning office, which referred to previous issues with enforcement, concerns over drainage and the impact the application could have on the site of special scientific interest which borders the land.

It was proposed by Cllr Brand and seconded by Cllr Kerr that the application should be approved.

7.2 <u>2022/0688/HSE</u> - Erection of two storey side extension Green End Edford Green Holcombe
